**CERTIFICATE OF AMENDMENT
OF CERTIFICATE OF INCORPORATION**

PACIFIC PRIDE BAKING COMPANY
(a Delaware corporation)

FIRST: That by unanimous written consent of the Board of Directors of Pacific Pride Baking Company, resolutions were duly adopted setting forth a proposed amendment of the Certificate of Incorporation of said corporation (the "Corporation"), declaring said amendment to be advisable and calling a meeting of the stockholders of the Corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Certificate of Incorporation of the Corporation be amended by changing the Article thereof numbered "FIRST" so that, as amended, said Article shall be and read as follows: The name of the corporation is **Bimbo Bakeries of California, Inc.**

SECOND: That thereafter, by unanimous written consent of the stockholders of said corporation in accordance with provisions of Section 228 of the General Corporation Law of the State of Delaware, gave their consent to this amendment.

THIRD: That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.

FORTH: That the capital of said corporation shall not be reduced under or by reason of said amendment.
