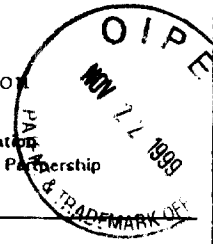



DECLARATION OF MASAO SUWA
CONFIRMING TRANSFER OF TRADEMARK REGISTRATIONS FROM
FUNAI USA CORPORATION TO FUNAI ELECTRIC COMPANY LIMITED

I, Masao Suwa, declare as follows:

1. I am Director of Funai Electric Company Limited, a corporation organized under the laws of Japan and having a place of business at 7-1, Nakagaito 7-chome, Daito-shi, Osaka, Japan, and I am authorized to make this Declaration on behalf of the corporation.
2. Funai Electric Company Limited is the owner of U.S. Trademark Registration No. 706,244 for the mark SYMPHONIC and U.S. Trademark Registration No. 1,133,541 for the mark SYMPHONIC & Design and the goodwill associated with these marks.
3. The owner of record of Registration Nos. 706,244 and 1,133,541, Funai USA Corporation, ceased to exist in or about June 1992.
4. Funai USA Corporation was, at all times, a wholly owned subsidiary of Funai Electric Company Limited.
5. When Funai USA Corporation ceased to exist, the parent company, Funai Electric Company Limited, acquired the trademarks of Funai USA Corporation and the goodwill of the business associated with the marks by operation of law.
6. All statements that I have made in this Declaration of my own knowledge are true and all statements that I have made on information and belief I believe to be true. I have made these statements with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and with the knowledge that such willful false statements may jeopardize the validity of this document and the registrations to which it pertains.
