

# TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made effective as of the 8th day of December, 1999, by and between Fremont Financial Corporation, having a place of business at 2020 Santa Monica Boulevard, Suite 600, Santa Monica, California 90404 (hereinafter referred to as the "Assignor"), and Fremont General Credit Corporation, having a place of business at 2020 Santa Monica Boulevard, Suite 600, Santa Monica, California 90404 (hereinafter referred to as the "Assignee").

WHEREAS, Assignor is the owner of common law rights in the marks FREMONT FREEDOM LOAN and FREEDOM FINANCIAL FREEDOM LOAN (the "Marks"), as set forth in U.S. Service Mark Applications Serial Nos. 75/617,792 and 75/617,789 (the "Applications"), together with the goodwill of the business symbolized thereby in connection with the promotion of financial lending services ("the Services"); and

WHEREAS, Assignor desires to convey, transfer, assign, deliver, and contribute to Assignee all of its right, title, and interest in and to the Marks and the Applications.

NOW, THEREFORE, Assignor and Assignee, in consideration of the mutual agreements herein contained and for other good and valuable consideration, acknowledged by each of them to be satisfactory and adequate, do hereby agree as follows:

1. Assignor hereby conveys, transfers, assigns, delivers, and contributes to Assignee all of Assignor's right, title, and interest in and to the Marks and the Applications, together with (1) the goodwill of the business relating to the Services with which the Marks are used and for which the Applications have been made; (2) all rights to sue for past, present, and future infringements or misappropriations of the Marks; and (3) all right, title and interest in the Applications.

2. Assignor further conveys, transfers, assigns, delivers, and contributes to Assignee all rights in the trade dress, labels, and designs associated with the Marks.

3. Assignor further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Marks.
