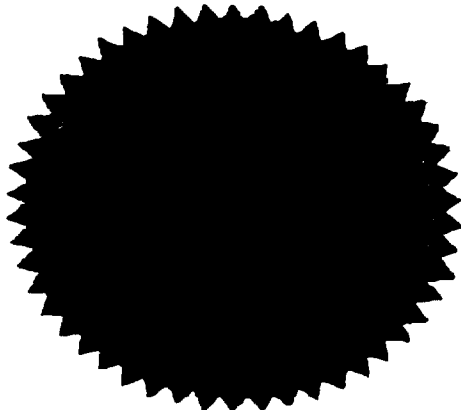

TO
ARTICLES OF INCORPORATION

The undersigned President of Signal Communication Systems and Supply Company, Inc. (the "Corporation") hereby submits these Articles of Amendment to the Articles of Incorporation of Signal Communication Systems and Supply Company, Inc. pursuant to the North Carolina Business Corporation Act, as amended.

**Article 1
Name of Corporation**

The name of the corporation is: "Signal Communication Systems and Supply Company, Inc."

**Article 2
Amendment**

The Corporation's Articles of Incorporation are hereby amended as follows:

Article 1 is hereby deleted in its entirety, and the following Article 1 is hereby substituted in lieu thereof:

"The name of the corporation is SIGCOM, Inc."

**Articles 3
Share Exchange**

The issued and outstanding shares of the Corporation's capital stock, the certificates of which bear the name "Signal Communication Systems and Supply Company, Inc.," shall be exchanged for replacement shares of the Corporation's capital stock, the certificates of which shall bear the name "SIGCOM, Inc.", within thirty (30) days of the Corporation's receipt from the North Carolina Secretary of State of confirmation of the filing and effectiveness of these Articles of Amendment.

**Article 4
Date of Adoption of Amendment**

The amendment set forth in Article 2 hereof was adopted by unanimous vote of the Board of Directors of the Corporation and by unanimous vote of the Shareholders of the Corporation, both votes having occurred on August 25, 1998.

Article 5
Shareholder Approval

Approval of the amendment set forth in Article 2 hereof by the Shareholders of the Corporation was obtained by the Corporation as required by the North Carolina Business Corporation Act, Chapter 55 of the North Carolina General Statutes, as amended.
