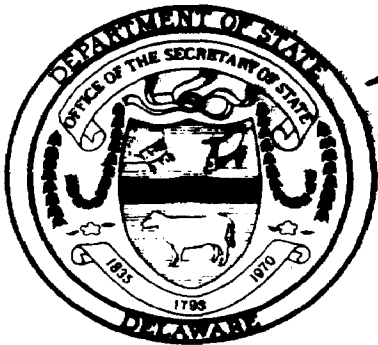

BENCHMARQ, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of BENCHMARQ, Inc., by the unanimous written consent of its members, filed with the minutes of the board, duly adopted resolutions setting forth a proposed amendment to the Certificate of Incorporation of said corporation, declaring said amendment to be advisable and directing that the proposed amendment be presented to the stockholders of said corporation for their consideration. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that Article First of the Corporation's Restated Certificate of Incorporation is hereby amended to read in its entirety as follows:


FIRST: That the name of the corporation is BENCHMARQ Microelectronics, Inc.
