RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated ^{As of} February 4, 2000 by Allied Capital Corporation and Allied Investment Corporation as hereinafter described;

WITNESSETH:

A. Allied Capital Corporation and Allied Investment Corporation (collectively the "Lenders"), each with a mailing address at 1919 Pennsylvania Avenue, N.W., Third Floor, Washington, D.C. 20006, and FTI Consulting, Inc., a Maryland corporation formerly known as Forensic Technologies International Corp. (the "Company") and its subsidiaries (the Company and its subsidiaries being referred to herein as the "Obligors"), each with a mailing address of 2021 Research Drive, Annapolis, Maryland 21401, are parties to a certain Security Agreement dated March 29, 1999, which was recorded in the United States Patent and Trademark Office on April 22, 1999, at Reel 1889, Frame 679 (the "Assignment"), pursuant to which, among other things, the Company granted a security interest in and collateral assignment of its trademarks listed on Schedule A attached hereto and certain other property described therein (collectively, the "Trademarks") as security for the indebtedness, obligations and liabilities owing by the Obligors to the Lenders under that certain Investment and Loan Agreement dated as of March 29, 1999, by and among the Obligors and the Lenders (herein, the "Loan Agreement"). All such indebtedness, obligations, and liabilities owing by the Obligors to the Lenders under the Loan Agreement and any of the other instruments and documents delivered pursuant thereto being referred to herein as the "Obligations".

B The Company has satisfied the Obligations and has requested that the Lenders release their security interests in the Trademarks and reassign the same to the Company.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Lenders hereby release their security interests in and collateral assignment of, and reassign, grant and convey to the Company, without any representation, warranty, recourse or undertaking by the Lenders, all of their right, title and interest, if any, in and to:

(i) Each Trademark and each Trademark Application listed on Schedule A attached hereto and made a part hereof, including without limitation all renewals thereof, all proceeds thereof (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements thereof, and all rights corresponding thereto throughout the world; and

(ii) The goodwill of the business to which each of the Trademarks relates.
