ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION OF  
American Century Financial Services

I.

The old name of the corporation is "American Century Financial Services." The new name of the corporation shall be "American Community Bank of Georgia."

II.

Article 1 of the Articles of Incorporation is amended to read as follows:

The Name of the Bank is:

*American Community Bank of Georgia  
a community bank*

The changes in the Articles of Incorporation made by these Articles of Amendment shall be effective upon the filing of these Articles of Amendment with the Georgia Secretary of State.

These amendments were duly approved by the Board of Directors of the corporation at a meeting held April 1, 1999, as authorized under Section 14-2-1002 of the Georgia Business Corporation Code, pursuant to (a) the Articles of Incorporation as they existed prior to these Articles of Amendment, and (b) the bylaws of the Corporation.
