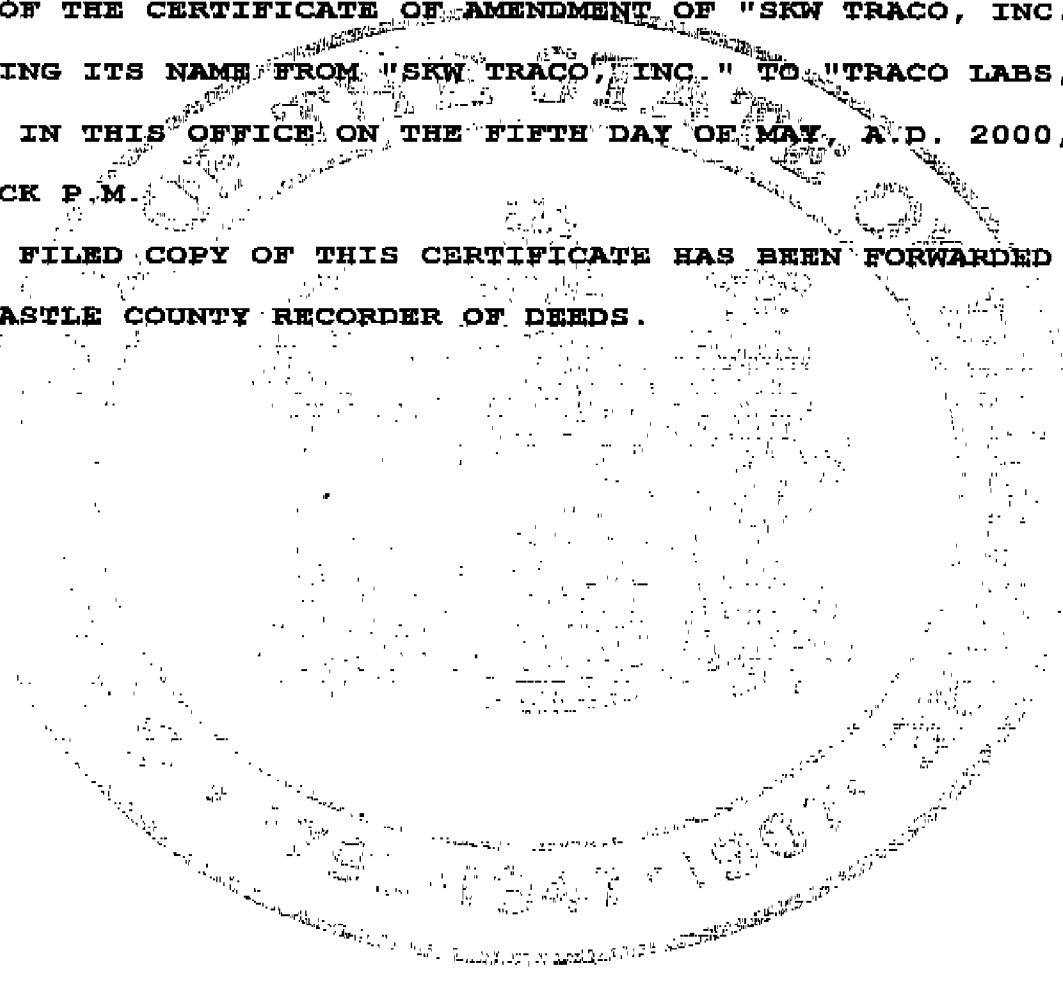

SKW TRACO, INC., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Company"), does hereby certify:

**FIRST:** That pursuant to a Written Action of the Board of Directors of the Company dated May 1, 2000, and authorized by Section 141 (D) of the General Corporation Law of the State of Delaware and Section 9 of Article III of the Bylaws of the Company, resolutions were duly adopted setting forth a proposed amendment of the Certificate of Incorporation of the Company, declaring said amendment to be advisable and calling a meeting of the stockholders of the Company for consideration thereof. The resolution setting forth the proposed amendment is as follows:

**RESOLVED**, that the Certificate of Incorporation of the Company be amended by striking Article 1 in its entirety and replacing therefor:

"1. The name of the corporation is TRACO LABS, INC."

**SECOND:** That thereafter, pursuant to resolution of its Board of Directors, by a Written Action dated May 1, 2000, and authorized by Section 228 of the General Corporation Law of the State of Delaware, and Section 11 of Article II of the bylaws of the Company, the sole stockholder of the Company voted all of the issued and outstanding shares of the Company in favor of the amendment.

**THIRD:** That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.


**FORTH:** That the capital of said Company shall not be reduced under or by reason of said amendment.
