UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW**

Pursuant to Section 805 of the Business Corporation Law of New York, as amended, Chilean Nitrate Corporation (the "Corporation"), a corporation duly organized and existing under the provisions of the Business Corporation Law of New York, certifies as follows:

1. The name of the Corporation is Chilean Nitrate Corporation. The Corporation was originally incorporated under the name Anglo-Chilean Nitrate Sales Corporation.
2. The Certificate of Incorporation of the Corporation was filed with the New York Department of State on the 31st day of August, 1927.
3. By a resolution adopted by unanimous consent in writing of the Board of Directors and shareholders of the Corporation dated April 27, 1999, in accordance with Sections 708(b) and 615, respectively, of the Business Corporation Law of New York, the first Article of the Certificate of Incorporation of the Corporation, such Article designating the corporate name of the Corporation, was amended in its entirety to read as follows:

**"FIRST. The name of the Corporation shall be
