1. The name of the Corporation (the "Corporation") is **Delta Food Group Inc.**
2. The Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on October 29, 1993.
3. The amendment to the Certificate of Incorporation of the Corporation effected by this Certificate of Amendment is to change the name of the Corporation to **Verion Incorporated.**
4. To accomplish the foregoing Amendment, Article **FIRST** of the Certificate of Incorporation is hereby amended to read in its entirety as follows:

"FIRST: The name of this corporation is **Verion Incorporated.**"

The foregoing Amendment was declared advisable by the Board of Directors of the Corporation pursuant to a resolution duly adopting the Amendment on July 8, 1999 and was duly adopted in accordance with the provisions of Sections 228 and 242 of the Delaware General Corporation Law by the written consent of the stockholders of the Corporation.
