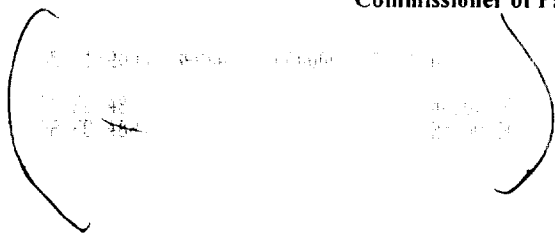

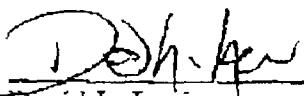
Article I shall be amended and restated to read in its entirety as follows:

"I.

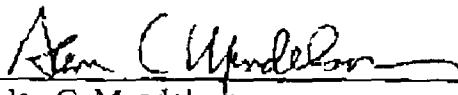
The name of corporation is ~~ISCRIBE~~, INC. (the "Corporation" or the "Company")."
