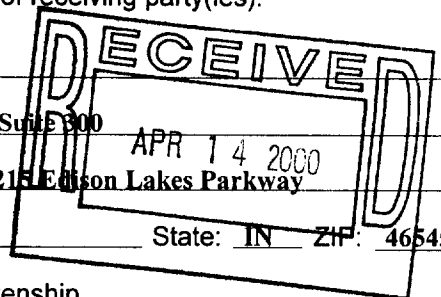

**ARTICLES OF MERGER**

**THE SUMMIT GROUP, INC.,  
an Indiana corporation**

**INTO**

**CIBER, INC.,  
a Delaware corporation**

Pursuant to the provisions of Articles 23-1-40-4 and 23-1-40-5 of the Indiana Business Corporation Law (the "IBCL") and Section 253 of the Delaware General Corporation Law (the "DGCL"), the undersigned hereby approve and adopt the following Articles of Merger for the purpose of merging The Summit Group, Inc. ("Summit"), an Indiana corporation and a wholly-owned subsidiary of CIBER, Inc., a Delaware corporation ("CIBER"), with and into CIBER.

1. On June 21, 1999, the Agreement and Plan of Merger (the "Plan"), attached as Exhibit A hereto, was adopted by the respective boards of directors of Summit and CIBER, in the manner prescribed by the IBCL and the DGCL.

2. Pursuant to Section 23-1-40-4 of the IBCL, neither the shareholders of Summit or CIBER are required to vote on the Plan.

3. The surviving corporation shall be CIBER, Inc., a Delaware corporation. The Certificate of Incorporation and the Bylaws of CIBER shall be the Certificate of Incorporation and Bylaws of the surviving corporation.

4. The effective date of the merger is June 30, 1999 at 11:59 pm Eastern Daylight Time.
