

ARTICLES OF INCORPORATION

OF

PBA TOUR, INC.

The undersigned, all of whom are citizens of the United States, desiring to form a non-profit corporation under Section 1702.01, et seq., of the Ohio Revised Code, do hereby certify:

FIRST:

The name of the Corporation shall be PBA TOUR, INC.

SECOND:

The place in the State of Ohio where the principal office of the Corporation shall be located is the City of Akron, County of Summit.

THIRD:

The specific non-profit purposes for which the Corporation is formed are the advancement of the common interests of the male professional bowler and of the bowling industry through the following activities: promoting the interests of the male bowler and elevating the qualified male bowler to the rank of professional; promoting bowling to the status of a major sport; promoting interest in the sport of bowling; protecting the mutual interests of its members; holding meetings and bowling tournaments periodically for the encouragement of its members; promoting a better understanding and working relationship between the professional bowler and the bowling proprietor, between the professional bowler and bowling manufacturer and between the professional bowler and the radio and television stations and networks and all other media outlets and press; engaging in any other kind of activity permitted under Section 501(c)(6) of the Internal Revenue Code of 1986, as amended from time to time, which the Corporation deems necessary or proper in order to fulfill its objectives of advancing the interests of professional bowlers and of the bowling industry, including, but not limited to, acquiring by gift or purchase, holding, conveying, mortgaging or leasing any property, real or personal, as may be necessary or incidental to the foregoing non-profit purposes; and entering into and performing contracts and agreements of every kind, necessary or incidental to, or in connection with, the foregoing non-profit purposes. The

Corporation is organized exclusively for the advancement of the interests of the male professional bowler and the bowling industry pursuant to Section 501(c)(6) of the Internal Revenue Code of 1986, as amended from time to time (the "Internal Revenue Code"), and shall at all times be operated in furtherance of said non-profit purposes as contemplated under Section 501(c)(6).

FOURTH:

The Corporation is organized exclusively for the advancement of the interests of the professional bowler and the bowling industry pursuant to Section 501(c)(6) of the Internal Revenue Code of 1986, as amended from time to time, and shall at all times be operated in furtherance of said non-profit purposes as contemplated under Section 501(c)(6).

FIFTH:

No part of the net earnings of the Corporation shall be distributed to, or inure to the benefit of, any member, trustee or officer of or contributor to the Corporation or to any other private individual. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a Corporation exempt from Federal income taxation under Section 501(c)(6) of the Internal Revenue Code of 1986, as amended from time to time.

SIXTH:

Upon the dissolution of the Corporation, the Board of Trustees of the Corporation shall, after paying and making provision for the payment of all liabilities of the Corporation, dispose of all assets of the Corporation in accordance with the non-profit purposes thereof in such manner as the Board of Trustees shall determine, and/or shall dispose of all assets to one or more other organizations organized and operated exclusively for such purposes as shall at the time qualify it or them as exempt organizations under Section 501(c)(6) of the Internal Revenue Code of 1986, as amended from time to time, as the Board of Trustees shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, in accordance with the non-profit purposes of the Corporation. In no event shall any assets of the Corporation be distributed to any member, trustee or officer of or contributor to the Corporation or to any other private individual, except and only the extent that such individuals are creditors of the Corporation.
