

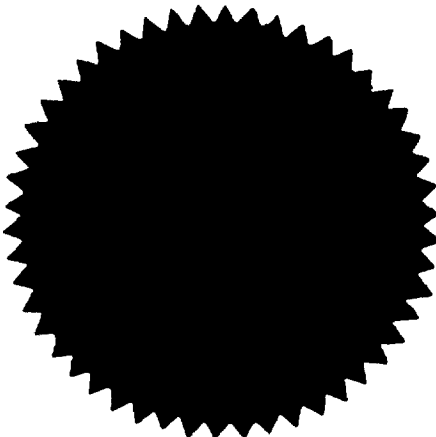

**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
HR EASY, INC.**

Pursuant to the provisions of Section 55-10-06 of the General Statutes of North Carolina, the undersigned corporation, HR Easy, Inc., a North Carolina corporation, adopts the following Articles of Amendment for the purpose of amending its Articles of Incorporation:

FIRST: The name of the corporation is HR Easy, Inc. (the "Corporation").

SECOND: In order to change the name of the Corporation, Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced with the following Article:

ARTICLE I - NAME


The name of this Corporation is Interim Assessment Services Inc. (hereinafter called the "Corporation").

THIRD: The date of adoption of this Amendment was April 27, 1999.

FOURTH: The foregoing Amendment to the Articles of Incorporation was duly adopted and approved by the Corporation's Board of Directors and by the Corporation's sole shareholder, Interim Services Inc., and such shareholder approval was obtained as required by Chapter 55 of the North Carolina General Statutes.
