W I T N E S S E T H :

WHEREAS, ASSIGNOR owns both common law and statutory rights in and to the various trademarks and trade names set forth in Exhibit A hereto (collectively, the “Quikbook Trademarks”).

NOW THEREFORE, in consideration of One Dollar, it is agreed by and between **ASSIGNOR** and **ASSIGNEE** as follows:

1. **ASSIGNOR** assigns, transfers and sets over unto **ASSIGNEE** the **ASSIGNOR’S** entire right, title and interest in and to the Quikbook Trademarks, together with the goodwill of the business associated with such trademarks, and the right to recover damages and/or profits from third parties which hereafter may arise from infringement or dilution of the Quikbook Trademarks.

2. The Quikbook Trademarks are to be held and enjoyed by **ASSIGNEE** and to inure to the benefit of its successors and assigns as fully and entirely as the same would have been held and enjoyed by **ASSIGNOR** had this assignment not been made, it being the intent of the parties hereto that the **ASSIGNOR** does hereby convey to **ASSIGNEE** all of **ASSIGNOR'S** right in the Quikbook Trademarks.
