

ASSIGNMENT

WHEREAS, Lady Burd Exclusive Cosmetics, Inc., a New York corporation, located and doing business at 44 Executive Boulevard, Farmingdale, New York 11735 (hereinafter "ASSIGNOR"), is the owner of the mark LIQUID LIPS for lip gloss and Trademark Application Serial No. 75/726,138, for said mark, filed in the United States Patent and Trademark Office on June 7, 1999 (hereinafter the "MARK"); and

ASSIGNOR does also hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the MARK and the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives; and

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States, whose duty it is to record trademark registrations, applications and title thereto, to record the MARK and title thereto as the property of the ASSIGNEE, its successors, legal representatives and assigns in accordance with the terms of this instrument.
