**TRADEMARK ASSIGNMENT**

WHEREAS, Propeller Creative Services, Inc. d/b/a Propeller Interactive Design and Development, a Kansas corporation ("Propeller") and RecordsCenter.Com, Inc., a Missouri corporation (formerly RecordsCenter.Com, LC, a Missouri limited liability company) ("RecordsCenter"), are joint owners of the entire right, title and interest in and to the trademarks listed on the attached Schedule A, identified by the Trademark Application Number referenced and issued on the date indicated (the "Trademark Rights"); and

Assignor further covenants and agrees that it will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect the title to the Trademark Rights in Assignee, its successors and assigns, and that it will, at any time upon request, communicate to Assignee, its successors and assigns such facts relating to the Trademark Rights or the history thereof as may be known to it.

Assignor further warrants that the Trademark Rights are not subject to any liens, encumbrances, mortgages, licenses, or other interests of third parties.
