

**TERMINATION AND RELEASE  
OF  
TRADEMARK COLLATERAL SECURITY AND PLEDGE AGREEMENT**

**TERMINATION AND RELEASE OF TRADEMARK COLLATERAL SECURITY AND PLEDGE AGREEMENT**, dated as of March 31, 2000, is by and between (1) **FLEET NATIONAL BANK** (f/k/a BankBoston, N.A.), a national banking association with an office at 100 Federal Street, Boston, Massachusetts 02110, in its capacity as Agent (hereinafter in such capacity, the "Agent") for itself and the other lending institutions (hereinafter, collectively, the "Banks") party to that certain Amended and Restated Credit Agreement, dated as of April 13, 1999, among American Reprographics Company, L.L.C., the Agent and the Banks, and under the Trademark Agreement (as defined herein) and (2) **FRANKLIN GRAPHICS CORPORATION**, a Michigan corporation having its principal place of business at 9000 Virginia Manor Road, Beltsville, Maryland 20705 (the "Company").

**WHEREAS**, pursuant to the terms of the Trademark Collateral Security and Pledge Agreement, dated as of August 19, 1999, between the Company and the Agent and recorded with the U.S. Patent and Trademark Office at Reel 1958, Frame 0776 (the "Trademark Agreement"), the Company granted to the Agent, for the benefit of the Agent and the Banks, a security interest in and lien on, and collaterally assigned to the Agent all of its trademarks, trademark registrations and associated goodwill, including, without limitation, the trademarks identified on Schedule A attached hereto (such trademarks referred to herein as the "Named Trademarks"); and

**WHEREAS**, the Agent has agreed to terminate and release its security interest and all of its right, title and interest in each of the Named Trademarks as herein provided;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent and the Company hereby agree as follows:


1. **Release and Assignment**. The Agent hereby terminates and releases its security interest in and first priority lien on all of the Company's Named Trademarks, and the Agent hereby assigns and transfers to the Company, without recourse, all of the Agent's right, title and interest in and to each of the Named Trademarks and the related trademark registrations and goodwill, effective as of the date set forth above.

2. **Acknowledgment and Acceptance**. The Company hereby acknowledges and accepts the foregoing release and assignment by the Agent.

3. **Counterparts.** This Release may be executed in any number of counterparts which shall together constitute one and the same agreement.



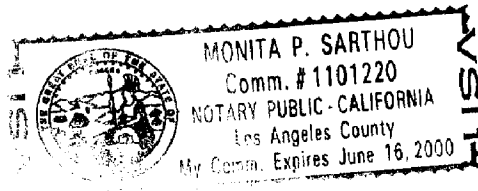
