GRANT OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, a Credit Agreement was entered into as of August 22, 2000 by and among DEVILS LLC, a Delaware limited liability company having its principal place of business at Continental Airlines Arena, 50 Route 120 North, East Rutherford, New Jersey 07073 (hereinafter, the "Borrower"), various lenders party thereto (collectively, the "Lenders"), and SOCIÉTÉ GÉNÉRALE, a French banking corporation having its principal place of business in the United States at 1221 Avenue of the Americas, New York, NY 10020 (hereinafter, "SG"), under the terms of which the Borrower and certain of the Borrower's subsidiaries have assumed certain obligations to the Lenders and SG; and

WHEREAS, in order to secure the performance of the Borrower and such subsidiaries of said obligations, the Borrower has agreed to grant a security interest in its trademarks to SG, as collateral agent;

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Borrower hereby conveys to SG, as collateral agent, a security interest in its entire right, title and interest in and to the trademarks listed on Schedule A hereto, and the goodwill of the Borrower's business associated with said trademarks.
