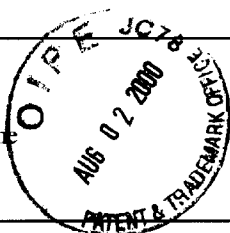

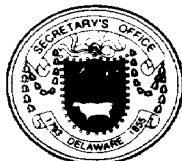

"The name of the Corporation is TeliSmart.com, Inc."


