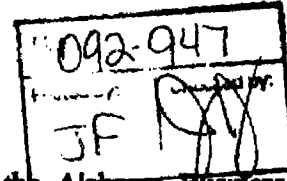

**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
AHLSTROM SERVICES INC.**



Pursuant to the provisions of Section 72, Act 80-633, known as the ~~Alabama Business Corporation Act~~, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Ahlstrom Services Inc.

SECOND: The following amendment of the Articles of Incorporation was adopted by the sole Shareholder and the Board of Directors of the Corporation on May 24, 2000, in the manner provided by the Alabama Business Corporation Act:

The name of the Corporation shall be changed to "Andritz-Ahlstrom Services Inc."

THIRD: The number of shares of the Corporation outstanding at the time of such adoption was two hundred fifty (250), and the number of shares entitled to vote thereon was two hundred fifty (250).

FOURTH: The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:

FIFTH: The amendment was authorized by the written consent of the sole Shareholder and the Board of Directors of the Corporation in lieu of a meeting.
