1. The name of this corporation is MarketScape, Inc., a Delaware corporation. The Corporation was originally incorporated under the name Selling Edge, Inc. and the original Certificate of Incorporation was filed with the Delaware Secretary of State on June 23, 1995.
2. This Certificate of Amendment amends the Amended and Restated Certificate of Incorporation pursuant to Section 242 of the General Corporation Law of the State of Delaware as set forth in Exhibit A attached hereto.
3. This Certificate of Amendment has been duly approved by the board of directors and recommended for approval to the stockholders.
4. This Certificate of Amendment has been duly approved by the required vote of stockholders pursuant to the requirements of Section 242 of the General Corporation Law of the State of Delaware. The total number of outstanding shares of Common and Preferred Stock of the Corporation is 28,719,610. The amendment was approved by a majority of the holders of Common and Preferred Stock voting together as a class. The total number of outstanding shares of Series B Preferred Stock, Series C Preferred Stock, Series D Preferred Stock and Series E Preferred Stock is 22,286,054. The Amendment was approved by a majority of the holders of Series B Preferred Stock, Series C Preferred Stock, Series D Preferred Stock and Series E Preferred Stock voting together as a class.

The undersigned hereby declares and certifies that the facts stated herein are true and has accordingly hereunto set his hand as of March 31, 2000.


