MEMORANDUM OF EXCLUSIVE LICENSE

THIS MEMORANDUM OF EXCLUSIVE LICENSE is made as of this 1st day of June, 1999, by and between *SEVENARTS LIMITED*, with its registered office located at 18 Albemarle Street, London W1X 3HA, England (hereinafter referred to as "Sevenarts"), and *STANDARD CHARTERED BANK*, with an office located at 7 World Trade Center, New York, NY 10048 (hereinafter referred to as "SCB" or "Licensee").

WHEREAS, Sevenarts and SCB have entered into that certain License Agreement of even date herewith (the "License Agreement"), with respect to the production, marketing, distribution, sale and other exploitation of Erté Fine Jewelry and Erté Costume Jewelry (such terms and all other capitalized terms used as defined terms and not otherwise defined herein shall have the meanings ascribed thereto in the License Agreement);

NOW THEREFORE, pursuant to the terms of the License Agreement, and incorporating and subject to all of the terms, definitions and provisions thereof, Sevenarts and SCB have agreed to execute this Memorandum of Exclusive License, and hereby agree as follows:

1. LICENSE

Pursuant to the terms of the License Agreement, Sevenarts grants to Licensee the worldwide, exclusive license to manufacture, market, distribute, sell and otherwise exploit Erté Fine Jewelry and Erté Costume Jewelry including, without limitation, the exclusive right to use the copyrights owned by Sevenarts and enumerated on Schedule A attached hereto and made a part hereof, to make derivative works as permitted therein, together with the exclusive right to use the "Erté" name, script signature, likeness and related trademarks (all as listed on Schedule B attached hereto and made a part hereof) in connection with the promotion, sale and other exploitation of Erté Fine Jewelry and Erté Costume Jewelry.

2. TERM


The initial term of the License Agreement shall be three (3) years, unless earlier terminated as provided in the License Agreement. The term shall be automatically renewed for successive three-year periods, unless Licensee gives written termination notice to Sevenarts prior to one hundred five (105) days before the expiration of the term, as the same may have been extended, subject to the other terms and provisions of the License Agreement, or unless earlier terminated as provided in the License Agreement.
