The undersigned, being all of the directors of Homestore.com, Inc. (the "**Company**"), hereby adopt the following resolutions by unanimous written consent.

**Appointment of Directors of The Homebuyer's Fair, Inc. and FAS-Hotline, Inc.**

WHEREAS, the Company has recently acquired all of the capital stock of each of The Homebuyer's Fair, Inc. ("**HBF**") and FAS-Hotline, Inc. ("**FAS**"); and

WHEREAS, in connection with the acquisition of HBF and FAS, the existing directors of HBF and FAS resigned; and

WHEREAS, the Board of Directors of the Company deems it advisable and in the best interests of the Company and its stockholders to appoint new directors of HBF and FAS; it is hereby

RESOLVED, that the following individual are appointed as the directors of the Company's wholly-owned subsidiary, HBF: Stuart H. Wolff, Ph.D. and John M. Giesecke, Jr..

FURTHER RESOLVED, that the following individuals are appointed as the directors of the Company's wholly-owned subsidiary FAS: Stuart H. Wolff, Ph.D. and John M. Giesecke, Jr.

FURTHER RESOLVED, that such action by the Company be effected and reflected by the signature of Stuart Wolff below on behalf of the Company.

**Merger of NSRS and CMR into HBF; Merger of FAS into HBF**

RESOLVED, that the Company, in its capacity as sole shareholder of HBF and FAS, hereby approves the business combination of HBF, FAS, and two wholly-owned subsidiaries of HBF, National School Reporting Services, Inc. ("**NSRS**") and The Center for Mobility Resources, Inc. ("**CMR**"), pursuant to the merger (which may be a short form merger if permitted by applicable law) of NSRS and CMR into HBF, with HBF as the surviving corporation, and the merger of FAS with and into HBF, with HBF as the surviving corporation, all pursuant to such agreement of merger and other agreements and instruments as the officers of HBF, FAS, NSRS and CMR, each of them acting singly, may in their discretion approve, their signature of any such agreements and instruments conclusively evidencing their authority to execute and deliver same on behalf of the respective companies.






