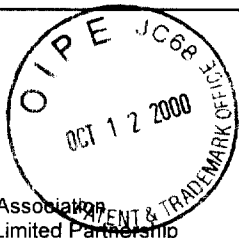

## RELEASE OF SECURITY INTEREST

This Release of Security Interest, *non pro tunc* as of December 28, 1999, by and between Arkansas National Bank, an Arkansas corporation, having a principal place of business at 3810 Front Street, Suite 11, Fayetteville, Arkansas 72703 and Bradley Holdings, L.L.C., having a principal place of business at 977 Oaks Manor, Fayetteville, Arkansas 72703. For good and valuable consideration, receipt of which is acknowledged and continuing payment to Arkansas National Bank under existing agreements, Arkansas National Bank does hereby release and discharge the security interest in the trademark shown in Schedule A attached hereto, and incorporated in this Release by reference, granted to it by Bradley Holdings, L.L.C., which Conditional Assignment is dated May 15, 1998, and which was recorded on July 20, 1999 at Reel 1931, Frame 0868 in the U.S. Patent and Trademark Office, to which reference may be had.

The referenced Conditional Assignment was entered with the intent to, *inter alia*, secure timely payment and performance and satisfaction of obligations in connection with certain Loan Agreement described in further detail in the Conditional Assignment.

At all relevant times, including upon execution of the Declaration of Use and Incontestability, dated December 28, 1999, Bradley Holdings L.L.C. owned and controlled the trademark referenced in Schedule A, including all associated good will, subject to an ongoing security interest in the trademark by Arkansas National Bank.

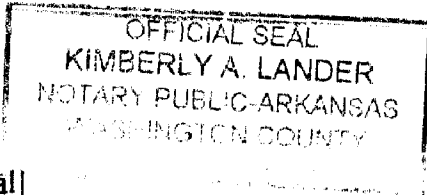
