

FURTHER RESOLVED, that the President or any Executive Vice President, Secretary or any Assistant Secretary be and hereby is authorized, empowered and directed to cause said name to be changed and to execute and deliver on behalf of the Corporation any Agreements or other documents which are required or, in the judgment of such officer, are necessary or desirable in connection therewith;

FURTHER RESOLVED, that the Secretary or any Assistant Secretary of the Corporation be and he hereby is authorized, empowered and directed to certify a true copy of these resolutions, that the Corporation is duly organized and existing, that it is empowered to enter into transactions of the types contemplated and that these resolutions are not in conflict with the Corporation's Charter or Bylaws or of any statute, rule, regulation, judgment, order, decree, agreement or undertaking to which the Corporation or its property is subject or bound.
