

# INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement is entered into as of October 17, 2000, by and between EIDOS INTERACTIVE, INC., a California Corporation ("*Assignee*") and ION STORM, L.P., a Delaware limited partnership ("*Assignor*").

## RECITALS

A. Assignee has agreed to extend certain financial accommodations to Assignee (the "*Advances*") in the amounts and manner set forth in that certain Software Development Agreement dated as of December 1996 by and between Assignee and Assignor (as the same may be amended, modified or supplemented from time to time, the "*Development Agreement*") and that certain Security Agreement by and between Assignee and Assignor dated of January 1997 (as the same may be amended, modified or supplemented from time to time, the "*Security Agreement*"; capitalized terms used herein are used as defined in the Security Agreement). Assignee is willing to make the Advances to Assignor, but only upon the condition, among others, that Assignor shall grant to Assignee a security interest in certain Copyrights, Trademarks and Patents to secure the obligations of Assignor under the Security Agreement.

B. Pursuant to the terms of the Security Agreement, Assignor has granted to Assignee a security interest in all of Assignor's right, title and interest, whether presently existing or hereafter acquired, in, to and under all of the Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of its obligations under the Development Agreement, Assignor hereby represents, warrants, covenants and agrees as follows:

## AGREEMENT

To secure its obligations under the Development Agreement, Assignor grants and pledges to Assignee a security interest in all of Assignor's right, title and interest in, to and under its Copyrights, Patents and Trademarks (including without limitation those Copyrights, Patents and Trademarks listed on **Schedules A, B and C** hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof.

This security interest is granted in conjunction with the security interest granted to Assignee under the Security Agreement. The rights and remedies of Assignee with respect to the security interest granted hereby are in addition to those set forth in the Security Agreement and the Development Agreement, and those which are now or hereafter available to Assignee as a matter of law or equity. Each right, power and remedy of Assignee provided for herein or in the Security Agreement or the Development Agreement, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or

remedy provided for herein and the exercise by Assignee of any one or more of the rights, powers or remedies provided for in this Intellectual Property Security Agreement, the Security Agreement or the Development Agreement or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including Assignee, of any or all other rights, powers or remedies.

IN WITNESS WHEREOF, the parties have cause this Intellectual Property Security Agreement to be duly executed by its officers thereunto duly authorized as of the first date written above.




