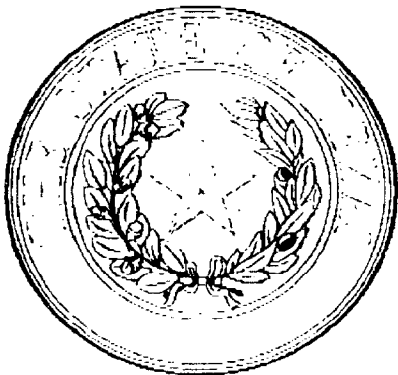

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned Corporation adopts these Articles of Amendment to its Articles of Incorporation (as previously amended, the "Articles of Incorporation").

ARTICLE I

The name of the Corporation prior to the effectiveness of this Amendment is A-1 TEMPORARY SERVICES, INC.

ARTICLE II

The following amendment to the Articles of Incorporation was adopted by the shareholders of the Corporation on July 21, 1998, which amendment alters and changes Article One of the Articles of Incorporation to change the name of the Corporation.

Article One of the Articles of Incorporation is hereby amended to read in its entirety as follows:

**"ARTICLE ONE
Name**

The name of the corporation is "InStaff Personnel of Texas, Inc." (hereinafter referred to as the "Corporation" or as the "Company").

ARTICLE III

The number of shares of the Corporation's common stock, one dollar (\$1.00) par value, outstanding at the time of the adoption of this amendment was 1,500, and the number of shares entitled to vote thereon was 1,500.

ARTICLE IV

The amendment contained herein does not provide for an exchange, reclassification or cancellation of issued shares. Further, the amendment contained herein does not effect a change in the amount of stated capital of the Corporation.


ARTICLE V
