THIS ASSIGNMENT is made the 3rd day of January, 2001 between Geneva Steel Interim Corporation, a Delaware corporation having its principal place of business at 10 South Geneva Road, Vineyard, Utah 84058 (hereinafter, "Assignor") and Geneva Steel LLC, a Delaware limited liability company having its principal place of business at 10 South Geneva Road, Vineyard, Utah 84058 (hereinafter, "Assignee").

Assignor's trademark rights, and further all the goodwill of the business associated therewith together with the existing and ongoing portion of the business to which the marks pertain.

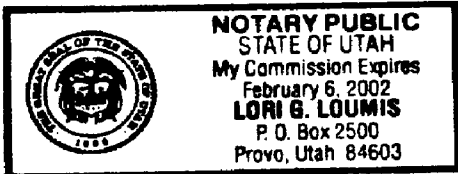
