NOW, THEREFORE, for good and valuable consideration set forth in the Agreement, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns, and transfers to Assignee, its successors and assigns, all of Assignor's right, title and interest in and to the Trademarks, including any registrations and applications thereof, together with the goodwill of the businesses symbolized by the Trademarks being assigned, in all countries of the world including the United States, its territories and possessions, all causes of action for any and all past infringements of the rights being assigned and the right to collect and retain the proceeds therefrom.

Assignor expressly agrees to execute, acknowledge and deliver such documents and other instruments that may be required to evidence or effectuate the sale, conveyance, assignment, transfer and delivery of the Trademarks to Assignee.
