1. **Constituent Entities.** The constituent entities are Silver Oak Partners, LLC, a limited liability company organized and existing under the laws of the Commonwealth of Massachusetts (the "Merged Company") and Silver Oak Partners, Inc., a corporation organized and existing under the laws of the State of Delaware (the "Surviving Corporation") (the Merged Company and the Surviving Corporation are collectively the "Constituent Entities").






