

**ASSIGNMENT DEED OF UNITED STATES TRADEMARK
REGISTRATION AND RELATED GOODWILL**

WHEREAS, MAVIC, INC., a Delaware corporation, having a principal address at 207 Carter Drive, West Chester, Pennsylvania 19382, (hereinafter referred to as "Assignor"), is the owner of and uses in its business the trademark MAVIC, which is the subject of United States Trademark Registration 1,508,035 MAVIC issued on October 11, 1988 at the United States Patent and Trademark Office for bicycles and parts and accessories therefor, namely, rims, wheels, wheel hubs, handlebars, steering gear, supports, saddle-pillars, pedals, crank-gear boxes, crank gears, derailleurs, gear levers, brakes in International Class 12; and

WHEREAS, MAVIC S.A., a France corporation, of Le Ripel, 01990, Saint Trivier sur Moignans, France (hereinafter referred to as "Assignee"), desires to acquire all of Assignor's right, title and interest in and to said Trademark along with all goodwill of the business connected with use of and symbolized by said Trademark, along with all common-law and statutory rights with respect thereto;

NOW THEREFORE; in consideration of payment of One Dollar (\$1.00) and other valuable considerations, receipt and sufficiency of which are hereby acknowledged by Assignor, Assignor has transferred, conveyed and assigned and hereby evidences such transference, conveyance and assignment to Assignee (as well as Assignee's successors and assigns) all of Assignor's right, title and interest in and to each of the following:

1. Said Trademark MAVIC and United States Trademark Registration 1,508,035 registered October 11, 1988 with the United States Patent and Trademark Office, together with all goodwill of the business in connection with which said Trademark is used.
2. All common-law and statutory rights with respect to said Trademark MAVIC.
3. All rights to bring legal action against any third party for and to recover damages in the United States for infringement of said Trademark MAVIC, including monetary damages for any past infringement thereof.

4. All rights to bring legal action and/or suits in equity in the United States against any and all third party(ies) and to seek injunctive and/or other equitable relief and/or to recover damages for unfair competition and/or other tortious conduct by any third party relating to the business conducted under said Trademark MAVIC, including but not limited to damages for such past unfair competition and/or other tortious conduct.


