## RELEASE OF TRADEMARKS

This Release of Trademarks (this "**Release**") is dated as of February 16, 2001 and is entered into by Canadian Imperial Bank of Commerce, as administrative agent for and representative of (in such capacity herein called "**Secured Party**") the Lenders (as hereinafter defined) and any Lender Counterparties (as hereinafter defined) for the benefit of Mitel Corporation, a corporation organized under the laws of Canada ("**Mitel**" and any other Loan Parties) regarding the Released Trademarks (as hereinafter defined). Pursuant to Section 9.6 of the Credit Agreement, Secured Party hereby acknowledges to Mitel and each other Loan Party party to a Security Deed, that Secured Party has released and discharged all of its right, title or interest of any kind or nature granted, assigned or conveyed pursuant to the Security Deeds in the Released Trademarks (as defined below).

As used in this Release the following terms have the following meanings:


"**Released Trademarks**" means the trademarks listed on Schedule A annexed hereto.

This Release shall be limited precisely as written and relates and applies solely to the Released Trademarks and the associated interests specifically described in clause (a) above.


