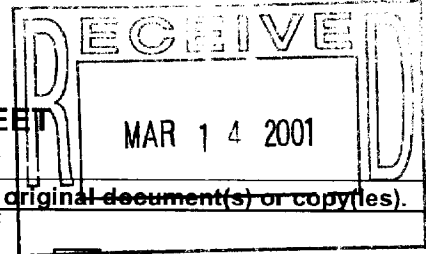

## CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS, on and before October 5, 1999 (hereinafter referred to as the "Effective Date"), Groupe Elite SA, a corporation which was organized and existing under the laws of Switzerland, which had offices at 15, route des Arsenaux, 1700 Fribourg, Switzerland (hereinafter referred to as the "Assignor") was the owner of the trademark ELITE MODELS FASHION and U.S. Trademark Application No. 75/592,865 filed November 20, 1998; and
