

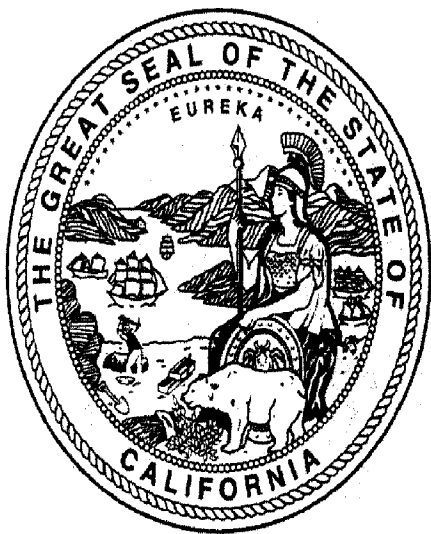

**CERTIFICATE OF AMENDMENT  
OF ARTICLES OF INCORPORATION**

1. That they are the president and the secretary respectively of PAGE, AKULIAN, HOLMES & BAKER, INC., a Professional Corporation, organized under California law.
2. That at a meeting of the Board of Directors of said corporation, duly held on January 3, 1995, the following resolution was adopted:
