

TRADEMARK ASSIGNMENT

This Assignment granted on this 28 day of February, 2001, by FOOTHILL CAPITAL CORPORATION, a California corporation ("Assignor") and K-5 LEISURE PRODUCTS, INC., a Nevada corporation ("Assignee"), as follows:

RECITALS

WHEREAS, K-TEL INTERNATIONAL, INC., a Minnesota corporation (the "Company") executed an Intellectual Property Security Agreement, dated November 19, 1997, in favor of Assignor, duly recorded on December 1, 1997, at Trademark Reel 1661, Frame 0406 in the United States Patent and Trademark Office (the "Agreement"), pursuant to which the Company assigned and granted to Assignor a security interest in and to all of the Company's right, title and interest in and to certain trademarks, service marks, trade names and applications therefor, as more specifically listed on Exhibit A attached hereto (the "Marks") and the goodwill associated therewith.

WHEREAS, the Assignor wishes to assign all of its right, title and interest in and to the Marks to the Assignee and to assign all of Assignor's liens, claims and encumbrances respecting the Marks, and the goodwill associated therewith, without representation or warranty (collectively, the "Rights").

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignor hereby assigns transfers and delivers its entire right, title and interest, including all rights of action and damages for past infringement, in and to the Marks and the Rights, together with the goodwill of the business in connection with which said Marks are used or as symbolized thereby, the registration for such of said Marks as are registered the same to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, licensees or other legal representatives.
