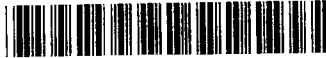

NUNC PRO TUNC TRADEMARK ASSIGNMENT

WHEREAS, TWENTYEIGHT, Inc., a Delaware corporation formerly named Press Access, Inc. (hereinafter referred to as "TWI"), having a place of business located at 120 Boylston Street, 10th Floor, Boston, Massachusetts 02116, has adopted, used or is using the trademarks as set forth on the attached Schedule A (hereinafter referred to as the "Trademarks"); and

WHEREAS, Reed Elsevier Inc., a Massachusetts corporation (hereinafter referred to as "Reed Elsevier"), having a place of business located 275 Washington Street, Newton, Massachusetts 02458, desired to acquire all right, title and interest in and to the Trademarks, including any choses in action relating to said Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof set forth on the attached Schedule A as part of the acquisition by Reed Elsevier of substantially all of the assets of TWI on August 31, 2000; and

covenanted, agreed and undertook to execute, whenever requested by Reed Elsevier, all applications, assignments, lawful oaths and any other papers which Reed Elsevier may deem necessary or desirable for securing to Reed Elsevier or for maintaining for Reed Elsevier the Trademarks hereby assigned, all without any further compensation to TWI.
