TRADEMARK ASSIGNMENT

This Trademark Assignment, made and entered into this 16 day of April, 2001, and between FRANCIS E. O'DONNELL, JR., an individual and a United States citizen, having an address at 709 The Hamptons Lane, Town & Country, Missouri 63017, herein after referred to as **O'DONNELL**, and COMPUPEN, INC., a Missouri corporation, located in St. Louis, Missouri, hereinafter referred to as **COMPUPEN, INC.**.

WHEREAS, **COMPUPEN, INC.** desires to obtain the assignment of all right, title and interest, in addition to the goodwill symbolized by said marks, of the aforesaid trademarks **COMPUPEN, PEN2NET, AND MEDIPEN**, from **O'DONNELL**.

NOW, THEREFORE, for consideration paid, and for \$1.00 additional consideration, the receipt of which is hereby acknowledged, **O'DONNELL** makes the following assignment to **COMPUPEN, INC.**, as follows:

O'DONNELL herein assigns all right, title and interest in and to the United States trademark registration upon the term **COMPUPEN**, registration No. 2,375,575, and also assigns herein the trademark application upon **PEN2NET**, Serial No. 76/100,312; and, **MEDIPEN**, Serial No. 76/100,313, said assignment of the trademarks and their registration and applications identified herein being an assignment of all right, title and interest in and to the identified trademarks, and their registrations, including the goodwill symbolized by the registration and

usage of said marks, and the consideration provided herein for said assignments includes One Dollar (\$1.00), and other good and valuable consideration, receipt of which is hereby acknowledge, by **O'DONNELL**; and further included in the Assignment herein is the right of **COMPUPEN, INC.** to initiate, undertake, prosecute, and pursue any claims for trademark and service mark infringement for any past infringements, perpetrated by others upon said marks, and their registration, and to retain any damages sustained thereby as a result of such infringing activity.
