NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Releasor hereby releases and discharges fully the Security Interest related to the Trademarks, and all other right, title and interest in the Collateral which may have been conveyed to Releasor (if any) pursuant to the Security Agreement and Assignment For Security (Trademarks), and Releasor reassigns without any representation or warranty of any kind or nature any and all such right, title and interest it may have (if any) in the Collateral to Releasee.
