TRADEMARK ASSIGNMENT



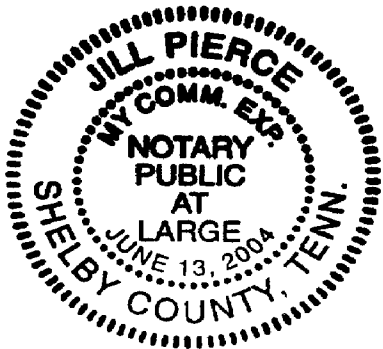


