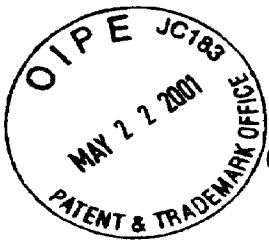

1. The Certificate of Incorporation of the Corporation is hereby amended by deleting Paragraph 1 thereof and inserting the following in lieu thereof:


"1. The name of the corporation is Tenneco Automotive Operating Company Inc."
