
"**FIRST:** The name of the Corporation is: Interoute-Wholesale, Inc."

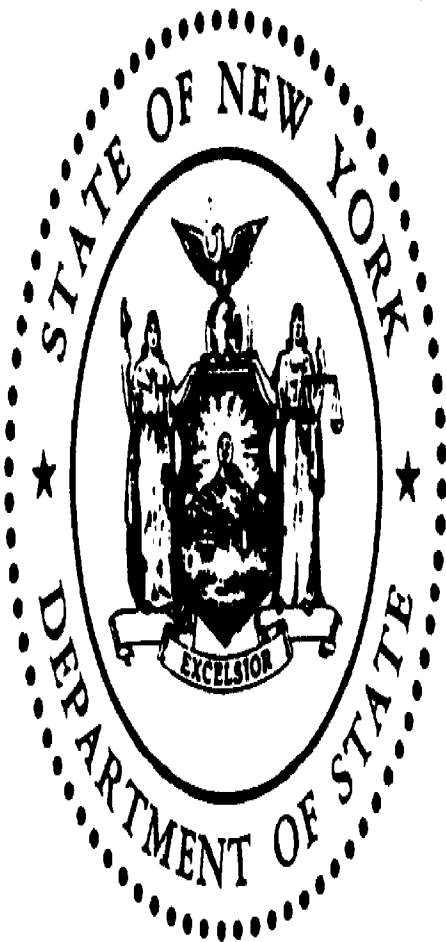
