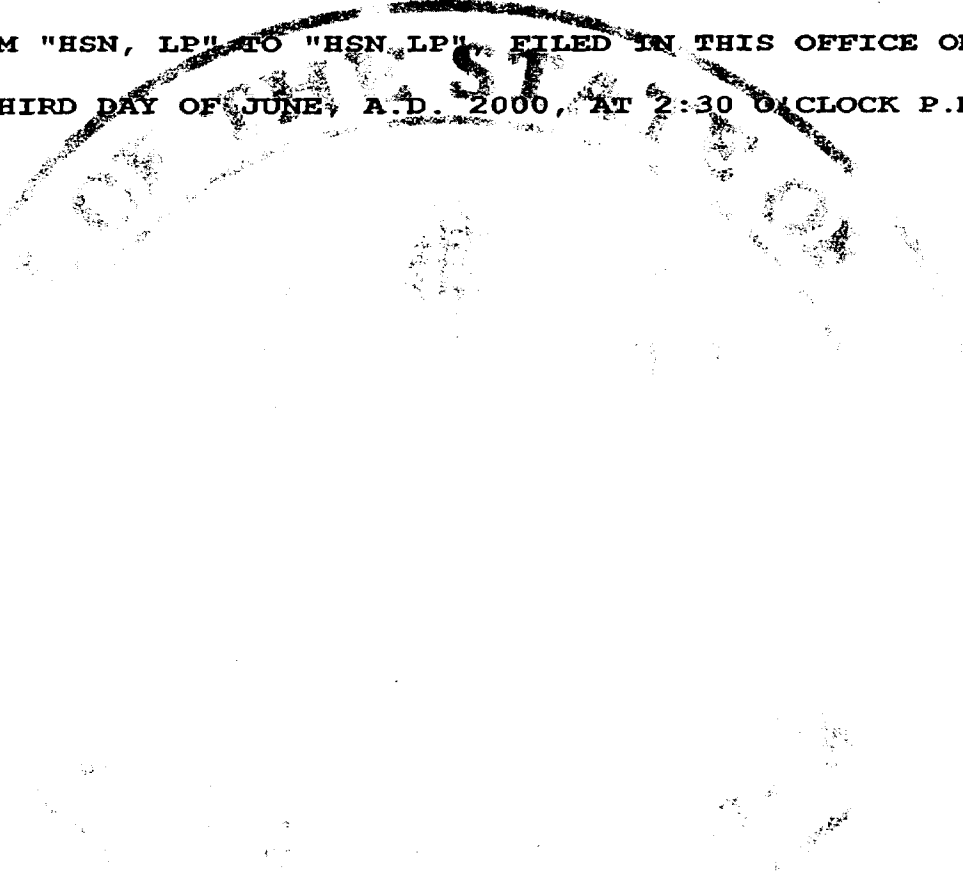


FIRST: The name of the Limited Partnership is HSN, LP.


