ASSIGNMENT OF UNITED STATES SERVICE MARK REGISTRATION

WHEREAS, Conrad's Tire Service, Inc., a corporation organized and existing under, and by virtue of, the laws of the State of Ohio, having an office and principal place of business at 14577 Lorain Avenue, Cleveland, Ohio 44111-3197 (hereinafter designated as ASSIGNOR), adopted and first used the mark PACT (hereinafter designated as "the said mark"); for which an I-T-U service mark registration was filed on April 27, 1992 as Serial No. 74/270,048;

WHEREAS, Professional Automotive Career Training, Inc., a corporation organized and existing under, and by virtue of, the laws of the State of Ohio, having an office and principal place of business at 14577 Lorain Avenue, Cleveland, Ohio 44111-3197, a wholly owned subsidiary of ASSIGNOR, and (hereinafter designated as ASSIGNEE) was desirous of acquiring any and all rights that ASSIGNOR may have in and to the said mark and the registration thereof;

WHEREAS, on March 2, 1995, ASSIGNOR filed its Statement of Use, executed February 15, 1995, which was subsequently accepted, following which Reg. No. 1,919,011 was granted;

WHEREAS, on March 2, 1995, ASSIGNOR concurrently executed an assignment of its aforesaid application to ASSIGNEE, recorded March 6, 1995 at Reel 1355, Frame 1234, although ASSIGNEE was not then, in fact, the successor to the business of the Applicant - ASSIGNOR;

WHEREAS, ASSIGNEE remains desirous of acquiring any and all rights that ASSIGNOR has in and to the said mark and the registration thereof, together with the goodwill of the business in connection with which the mark is used and which is symbolized by the said mark, along with the right to recover for damages and profits for past
