CHANGE OF NAME

As a result to the provisions of the Colorado Business Corporation Act, § 7-110-106, C.R.S. 1992, as amended, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation filed December 10, 1997:

**FIRST:** The name of the corporation is **PULMONARY DATA SERVICE, INC.** *new*

**SECOND:** The following amendments to the Articles of Incorporation as previously amended is hereby adopted by the corporation:

Article I of the Articles of Incorporation is hereby amended to read as follows:

"The name of this corporation shall be **PDS INSTRUMENTATION, INC.**

**THIRD:** The Amendment does not provide for an exchange, reclassification or cancellation of issued shares.

**FOURTH:** The foregoing amendment to the Articles of Incorporation of the corporation was adopted effective December 31, 1999 by the shareholders and directors of the corporation.
