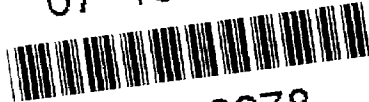

## ASSIGNMENT OF TRADEMARKS




