SECOND: That PRO-CHEM, INC., a corporation organized
and existing under the laws of the State of Ohio, was
incorporated on the 7th day of August, 1953, pursuant to

RESOLVED, that the proper officers of the Corporation be, and they hereby are, authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware, that may be in any way necessary or proper to effect the merger provided for by these resolutions."
