**ASSIGNMENT OF MARKS**

This Assignment of Marks effective this 3rd day of August, 2000, between GENICOM CORPORATION, a Delaware corporation; GENICOM INTERNATIONAL LIMITED, a United Kingdom corporation; GENICOM INTERNATIONAL SALES CORPORATION, a Delaware corporation; and GENICOM INTERNATIONAL HOLDINGS CORPORATION, a Delaware corporation; each having a place of business at Genicom Drive, Waynesboro, Virginia 22980 (hereinafter collectively referred to as "ASSIGNOR") and GENICOM, LLC, a Delaware limited liability company, having a business address of 4500 Daly Drive, Chantilly, Virginia 20151 ("ASSIGNEE").

WHEREAS, pursuant to the Asset Purchase Agreement, ASSIGNOR agreed to assign, and ASSIGNEE agreed to acquire ASSIGNOR'S entire right, title and interest in and to said Marks set forth at least in the attached Schedules A, B and C.

Any and all reasonable expenses incurred by ASSIGNOR in connection with its obligations under this paragraph shall be paid by the ASSIGNEE (or its assigns).
