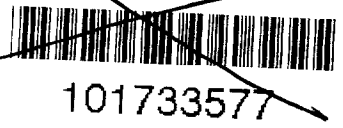

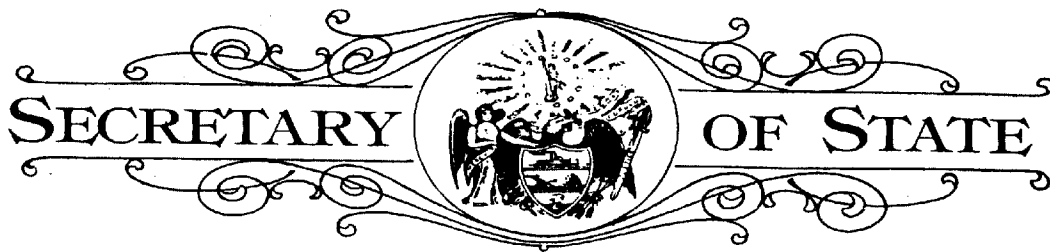

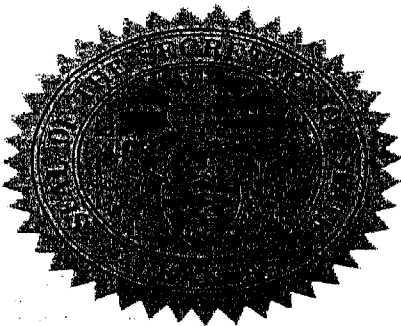

B. Upon recommendation of the Board of Directors, the shareholders have unanimously adopted the following amendment:


The name of the corporation is SUN ERGOLINE, INC.

C. The date of adoption of the amendment was August 15, 2000.


D. The number of shares outstanding is 575, all of one class and all are entitled to vote.
