**TRADEMARK ASSIGNMENT**



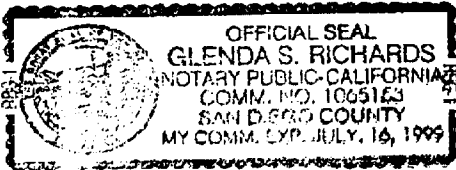
